3. ‘STARTING PRICE’ as indicated in the e-auction notification published, may not be considered as the ‘RESERVE PRICE’. Reserve price for the lot has been fixed by the competent authority and the same has been kept confidential. The highest bidder will be considered on the basis of the Reserve price fixed by competent authority and not on the basis of the starting price.
4. The dates and times published online are final and no request for any change will be entertained under any circumstances. Moreover, no objection in any form shall be entertained after the completion of on line scrutiny of documents. 8. The earnest money deposited by H1 will be refunded only after satisfactory completion of work, to be certified by the competent authority of Patrasayer Mahavidyalaya.
9. Auction materials, rubbish, the hard fibrous lignified substance under the bark of trees to be collected from mentioned addresses at the purchaser's own arrangement (viz. vehicles and manpower for loading). No expenses in any form towards disposal will be borne by Patrasayer Mahavidyalaya.
10. Road challan for the disposal will be provided by the concerned Authority of College. However, all other permits/permission are quirked for transportation and disposal will have to be arranged by the purchaser. Disposal of the dismantled materials/goods have to be arranged as per relevant traffic rules of the area. All such type of incidental costs have to be considered by the bidders while quoting their bid/offer. No such payment shall be made by the auction inviting authority.
